

# **Application Form Housing Act 2004**

Appeals relating to HMO and non-HMO Licence Decisions

This is the correct form to use if you are an owner or manager of premises and you wish to appeal against a decision of a Local Housing Authority to grant or not to grant a Licence or to vary or revoke or to refuse to vary or revoke a Licence under paragraphs 31(1) or 32(1) of Schedule 5 to the Housing Act 2004.

#### **Documents**

You must send the following document(s)("required document(s)") with this application:

Where the appeal relates to the grant of a Licence:

- a copy of the notice proposing to grant the Licence together with a copy of the proposed licence and the reasons for granting the Licence;
- a copy of any notice proposing to grant the Licence with modifications (if any) together with the modifications and the reasons for the modifications;
- a copy of the notice setting out the reasons for the decision to grant the Licence;
- a copy of the Licence.

Where the appeal relates to the refusal to grant a Licence:

- a copy of the notice setting out the reasons for the proposed refusal;
- a copy of the decision not to grant the licence and the reasons for the decision.

Where the appeal relates to the variation or revocation of a Licence:

- a copy of the notice setting out the effect of the proposed variation of or the proposal to revoke the Licence and the reasons for doing so;
- a copy of the decision to vary or revoke the Licence together with the reasons for doing so;
- a copy of the Licence.

Where the appeal relates to the refusal to vary or revoke a Licence:

- a copy of the notice setting out the proposed reasons for refusal;
- a copy of the decision not to vary or revoke the Licence and the reasons for the decision;
- a copy of the Licence.

Failure to send any required document(s) might make this application invalid.

Please do not send any other documents at this time. If and when further documents, information or evidence are needed, you will be asked to send them separately.

#### Time Limits

The application must be made within 28 days of the date on which the decision was made.

#### Application Fee

Unless you are entitled to a waiver, you must send the Application Fee of £155 with the application and the required documents.

The Fee must be paid by crossed cheque or postal order drawn in favour of "Welsh Government", or by bank transfer details of which are available on request.

Do not send cash under any circumstances. Cash payments will not be accepted.

#### Please note:

If you do not send the correct fee payable to or in favour of "Welsh Government" or if you send cash, the application and cash will be returned to you at your risk.

#### Waiver of Fees

If the Applicant(s) or the partner(s) of any Applicant(s) is/are in receipt of certain income related benefits, the Application Fee may be waived.

To claim a waiver of the Application Fee, the Applicant(s) in receipt of benefit or the Applicant(s) whose partner(s) is/are in receipt of such benefit must complete a waiver application form which can be obtained from the Residential Property Tribunal. This will not be copied to other parties.
